

## EdTrust Analysis of Hate Crimes on College Campuses by Accreditor

EdTrust analyzed the most recently available Clery data to better understand the increase in instances of crime on college campuses. Focusing on the organizations tasked with ensuring educational quality for students on campus, our Clery data analysis focuses on the six major U.S. accrediting agencies (see Table 1), which serve the following regions: New England (NECHE), Middle States (MSCHE), North Central (HLC), Southern (SACSCOC), Western (WASC), and Northwest (NWCCU). Although the functions and practices of institutional accrediting agencies differ, they share a responsibility to ensure that the institutions they accredit meet basic standards of quality, effectiveness, and integrity. They do this in various ways, such as reviewing faculty qualifications, student support services, and institutional policies, or by requiring institutions to submit improvement plans, collect and report data, and undergo periodic reviews.

To assess the landscape of hate crime incidents at institutions accredited by the six major U.S. accrediting agencies, hate crime data from 2015-2021 was collected from the <u>Campus Safety and Security (CSS)</u>. We exclusively focused on four-year public and private nonprofit institutions in the 50 U.S. states and Washington, D.C., that enroll more than 1,000 students and have on-campus housing facilities.

The CSS data shows that across the 1,338 institutions in our sample, there were more than 4,200 reported on-campus hate crimes between 2015 and 2021. When adjusted for differences in student enrollment, this means there were 6.47 reported hate crimes for every 100,000 full-time enrollment (FTE) students (see Table 2). Institutions accredited by NECHE had the highest rate of reported hate crimes, with 12.97 per 100,000 FTE; followed by MSCHE, with 9.95; and NWCCU, with 7.54. SACSCOC institutions reported the lowest rate, at 3.23 per 100,000 FTE, which was significantly below the average.

The three most prevalent types of hate crimes — intimidation, destruction of property, and simple assault — collectively accounted for 94% of all reported incidents. With 1,758 cases of intimidation, 1,703 cases of destruction of property, and 390 cases of simple assault, these figures suggest that most hate crimes are meant to instill fear, cause physical harm, or damage property, and directly undermine the sense of security and belonging of students from various under-represented groups.

More than half of all reported hate crimes were motivated by bias over race, ethnicity, or national origin — followed by sexual orientation and religion, which accounted for 19.5% and 16.9% of incidents, respectively. These statistics highlight how unwelcoming and challenging some academic settings can be for people of color, LGBTQ people, and religious minorities, who are disproportionately more likely to be targets of hate-driven attacks.

The data also reveals patterns between types of crimes and their motivators (see Table 3). For instance, hate crimes of property destruction were often motivated by racial or ethnic bias, while hate crimes of intimidation against individuals were more commonly motivated by racial bias or a bias against a certain sexual orientation or religion. The vast majority — 90% — of reported rapes were motivated by the victim's gender identity or sexual orientation, and nearly 60% of reported thefts were driven by bias against a person's religion or sexual orientation. These patterns only underscore the need for targeted preventive measures and educational initiatives to counter biases and reduce the prevalence of hate crimes, while promoting a safer, more inclusive campus environment.

Next, we identified notable variations in the motivating factors for hate crimes between accreditors (see Tables 4A and 4B). Race was the most predominant factor across all accreditors, ranging from 36.9% for WASC to 47.7% for SACSCOC. Sexual orientation was the second most common motivating variable, with variability ranging from 14.0% at MSCHE institutions to 25.1% at SACSCOC institutions. Interestingly, the rate of hate crimes motivated by bias against a religion was significantly higher at WASC institutions (28.7%), while the rates of crimes motivated by bias against a person's race or gender were lower at WASC institutions than at institutions in other accreditors' regions.

While destruction of property and intimidation were the most common types of crimes committed across all the accrediting regions (see Table 5A), there were outliers. Institutions in states where NECHE is the primary accreditor had a particularly high percentage of intimidation reports at 50.6% (see Table 5B). Meanwhile, the incidence of larceny-theft was notably higher in states where WASC is the primary accreditor — at 15.1% of reported crimes (see Table 5B). This may be connected to the high rate of religiously motivated hate crimes in states where institutions are primarily accredited by WASC, as larceny-theft crimes were most attributed to biases against religion and sexual orientation.

More serious crimes, such as rape, aggravated assault, and murder, were rare across all accrediting regions, emphasizing how prevalent and impactful crimes like destruction of property and intimidation appear to be in students' everyday lives.
